Siding color: Mr. Davis made a motion to keep the T1-11 as the same color of the building. Ms. Jones seconded. All in favor, motion carried.

Unit 401: windows and siding. It affects unit 106

Mr. Davis made a motion to approve the Siding replacement for units 401, 402, 403 and 404. Unit 401 will pay \$4620.00. Unit 402 \$8515.00. Unit 403 \$2600.00. Unit 404 \$15825.00. The cost to the association is \$42775.00 This cost must be considered in the 2026 budget.
